2023-24 School Safety Plan

Santee Success Program is on the campus of Cajon Park School and as such are part of the Cajon Park School Safety Plan. The Comprehensive School Site Safety Plan was developed in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy. Staff responsibilities and safety plan updates were discussed with staff in September, 2023. The Cajon Park SSC reviewed and approved the plan on November 27, 2023.

Professional Development

All training and curriculum development activities at the Santee Success Program support the implementation of Common Core Content Standards and State curricular frameworks. All teachers, district-wide, annually receive between 3 - 8 days of professional development at the site and/or district level. Decisions concerning selection of staff development activities are performed by the principal, district administrators, and grade level representatives using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Santee Success Program certificated staff receive support through peer coaching and mentoring. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job related training from department supervisors and district representatives. All training days for 23-24 are partial days, except the initial district-wide training day.
